WHEREAS, the Madison Local School District Board of Education entered into a contract with Petermann LLC to provide transportation services for the Madison Local School District commencing at the start of the 2005-2006 school year; and

WHEREAS, all of the individuals employed by the Madison Local School District as school bus drivers were offered employment by Petermann as school bus drivers; and

WHEREAS, the individuals employed by the Madison Local School District as school bus drivers were advised by authorized representatives of the Board of Education that they would not lose their accumulated sick leave and right to severance pay upon retirement under the School Employees Retirement System if they accepted Petermann's offer of employment; and

WHEREAS, because the individuals who were employed by the Madison Local School District as school bus drivers are no longer employed by the School District, it is necessary to formally authorize the payment to them of severance pay, based on their years of service to the Madison Local School District, upon their retirement under the School Employees Retirement System.

NOW, THEREFORE, BE IT RESOLVED that: An individual who was employed by the Madison Local School District as a school bus driver at the time the Board of Education contracted with Petermann LLC to provide the School District's transportation services, and who accepted employment with Petermann at the time the individual's position as school bus driver for the School District was abolished, shall be paid for one-fourth of the individual's sick leave days accumulated as of the time the individual ceased being employed by Madison Local School District and began employment with Petermann, less any of such accumulated sick leave days used while in Petermann's employ. The maximum of days for which severance pay shall be paid is 51 days. The rate of pay for such accumulated sick leave days shall be the individual's per diem rate of pay as a Petermann employee at the time of the individual's retirement. The individual must be employed by Petermann at the time of retirement. In the event of the death of the individual while employed by Petermann, the severance pay provided for in this Resolution shall be paid to the individual's estate.
