RESOLVED, to approve the continuing of the Interdistrict Open Enrollment Policy for the 2008-2009 school year in accordance with the State guidelines and the policies and guidelines for the District.

Discussion:

Dr. Cline read the Interdistrict Open Enrollment Checklist required by the Ohio Department of Education:

- A. The Board of Education of this school district has adopted a resolution establishing for the school district the following policy: A policy that permits enrollment of students from **all other districts** in accordance with policy statements contained in the resolution.
- B. Provisions school districts must adopt in an interdistrict open enrollment policy:
 - 1. Policy must be adopted by the board of education that allows or entirely prohibits interdistrict open enrollment.
 - 2. Policy must contain application procedures including deadlines for application and notification of acceptance or rejection.
 - 3. Set district capacity limits by grade level, school building and educational program.
 - 4. Resident students and any adjacent or other district student previously enrolled in interdistrict open enrollment must be given priority.
 - 5. Policy must insure proper racial balance is maintained.
 - 6. School board's rationale and definition for the objection of native students is a negative racial balance is created.
- C. Interdistrict policies shall not include any of the following:
 - 1. A requirement for athletic, academic or any other skill or proficiency.
 - 2. Limitation on enrollment because of handicapping condition.
 - 3. A requirement that a student be proficient in the English language.
 - 4. Rejection of an application because he/she has been disciplined, except if a student has been suspended or expelled for 10 or more days in the current term or in the immediately preceding term.
 - 5. Refusal to accept credits earned in interdistrict open enrollment.
 - 6. A policy that in any way discourages a native student from participating in interdistrict open enrollment.

Dr. Cline read the following from O.R.C. 3313.98 Procedures for enrolling students from adjacent districts or other districts.

- (B) (1) The board of education of each city, local, and exempted village school district shall adopt a resolution establishing for the school district one of the following policies:
 - a) A policy that entirely prohibits the enrollment of students from adjacent districts or other districts, other than students for whom tuition is paid in accordance with section 3317.08 of the Revised Code;
 - b) A policy that permits enrollment of students from all adjacent districts in accordance with policy statements contained in the resolution;
 - c) A policy that permits enrollment of students from all other districts in accordance with policy statements contained in the resolution.
- (2) A policy permitting enrollment of students from adjacent or from other districts, as applicable, shall provide for all of the following:
 - a) Application procedures, including deadlines for application and for notification of students and the superintendent of the applicable district whenever an adjacent or other district student's application is approved.
 - b) Procedures for admitting adjacent or other district applicants free of any tuition obligation of the district's schools, including, but not limited to:
 - (i) The establishment of district capacity limits by grade level, school building, and education program;
 - (ii) A requirement that all native students wishing to be enrolled in the district will be enrolled and that any adjacent or other district students previously enrolled in the district shall receive preference over first-time applicants;
 - (iii) Procedures to ensure that an appropriate racial balance is maintained in the district schools
 - c) Except as provided in section 3313.982 of the Revised Code, the procedures for admitting adjacent or other district students, as applicable, shall not include:
 - 1. Any requirement of academic ability, or any level of athletic, artistic, or other extracurricular skills;
 - 2. Limitations on admitting applicants because of disability, except that a board may refuse to admit a student receiving services under Chapter 3323. of the Revised Code, if the services described in the student's IEP are not available in the district's schools'
 - 3. A requirement that the student be proficient in the English language;
 - 4. Rejection of any applicant because the student has been subject to disciplinary proceedings, except that if an applicant has been suspended or expelled by the student's district for ten consecutive days or more in the term for which admission is sought or in the term immediately preceding the term for which admission is sought, the procedures may include a provision denying admission of such applicant.
- (D)(1) Each school board permitting only enrollment of adjacent district students shall provide information about the policy adopted under this section, including the application procedures and deadlines, to the superintendent and the board of education of each adjacent district and, upon request, to the parent of any adjacent district student.
- (2) Each school board permitting enrollment of other district students shall provide information about the policy adopted under this section, including the application procedures and deadlines, upon request, to the board of education of any other school district or to the parent of any student anywhere in the state.
- Dr. Cline also read from the Administrative Guidelines: Students 5113:

- E. Applications for admission from other Ohio districts may be submitted to the Superintendent from the first school day in May up to the last Friday in June. Applications must be picked up and returned in person. No applications received by other methods will be accepted.
- H. Applications will be acted upon no later than August 15th.
- I. The Superintendent may waive the stated enrollment deadlines up to the first full week of October should extenuating circumstances exist.
- J. If at any time prior to the start of the school year, the enrollment of a new Madison district student brings a specific class or program enrollment to optimum size, the applications of students from other Ohio districts shall be revoked in reverse order of acceptance (last in-first out). However, students from other Ohio districts who have begun the program shall be allowed to complete the school year.

Dr. Cline explained the Ohio High School Athletic Association (OHSAA) rules regarding student transfers: All but freshmen will be ineligible to participate for the first year at Madison except for Exception 5: --a student may transfer to a different school and be eligible provided the superintendents of both districts enter into a written agreement that consents to the attendance and specifies that the purpose of such attendance is to protect the student's physical or mental well-being. Only one such exemption shall be permitted in any four school years. The student shall not be eligible until declared eligible by the Commissioner upon submission of the exemption form.

Mr. Cappel: Asked about the Building LFI budget and the performance of open enrollment students.

Mr. Philpot: The majority of the open enrollment students are in the middle academically.

Mr. Cappel: Disputes economics of open enrollment – student/teacher ratios, open enrollment revenue; believes that open enrollment negatively impacts academic performance and that taxpayers will have higher burden due to open enrollment.

Mr. Young asked if any teachers have complained about having too many students.

Dr. Cline answered that there were some complaints.

Mr. Farler asked if we had complaints prior to open enrollment?

Dr. Cline replied that he was not here prior to open enrollment, but we are not exceeding state maximums for student/teacher ratios at any grade level.

Mr. McGuire: Will the open enrollment policy affect any current students for athletics (i.e., setting out a year)?

Dr. Cline: No current athletes will be impacted since they will have attended Madison for one year.

Amy Schenck was recognized by the Board to speak: Will the year of ineligibility for first year open enrollment students affect students in non-athletic extra-curriculars?

Dr. Cline: Only athletics are covered by eligibility guidelines.

Mr. Dulle: We make no extra bus stops for open enrollment students.

Mr. Cappel: Everything costs money – we'll see at tax levy time.

Mr. Farler: Open enrollment did not increase class sizes appreciably.

Mr. French: Open enrollment revenue projection should use 0 instead of 40 open enrollment students.

Mr. Zimov: That may produce an unrealistically negative financial picture as long as program quality is favorable.

Board of Education Reports/Communications:

Butler Tech Report – Mr. McGuire: Butler Tech is going through the Ohio School Facilities Commission building process, possibly to build along I-75. Five or six scenarios are under considerations. What programs will be in the new building will be decided later in the process.

Legislative Report – Mr. French:

- Senate Bill 148 SERS Eligibility signed by the Governor on February 13, 2008, effective in 90 days (revises the retirement eligibility requirements for members of the School Employees Retirement System.
- House Bill 142 became effective on March 11, 2008 (authorizes State Highway patrol to provide emergency assistance to schools confronted with bomb threats or similar threats increases penalty to a second degree felony when a school is involved.
- House Committee held hearings to discuss budget cuts ordered by Gov. Ted Strickland for \$10 million for 2008 and 2009. (ODE spreadsheet copies available)
- House considering Senate Bill 221 (Alternative energy proposal); this will impact school districts and the rates they pay for electricity. OSBA is developing a proposal through the Education Tax Policy Institute for special consideration of school districts. Testimony to be given in the House Public Utilities Committee.

Student Achievement Report – Mr. Farler: Thanks to the Washington D.C. trip students and we support more learning activities that impact the community. Suggested that student board members might be a part of the system and could have a positive impact. He will investigate having such a program.

Communications - Dr. Cline: Read a letter from Julie and Mason Conley expressing gratitude for the Washington D.C. trip.

Board Member Comments:

Mr. Young: The Washington D.C. trip was an exciting and thought-provoking experience. The teachers did a great job.

Mr. Cappel:

- Now that the open enrollment matter is decided for next year, we welcome all open enrollment students because kid's education is more important than money.
- Would like to consider random drug testing for non-union employees on the agenda at the next meeting and would also like to add random drug testing to the negotiations with the teachers' union.
