Joe Statzer – Butler County Auditor's Office: Visiting taxing districts to explain the process and what to expect from this year's unscheduled reevaluation.

- Dog tags will be going up effective January 1, 2010 are now on sale
- Homestead Exemption applications are available; seniors save on the average of \$400 of Market Value for tax purposes
- Economy changed necessitating an update to more accurately reflect taxable values; took out 2005 values in 2008 reappraisal. Current reevaluation is using 2008 and 2009 values. Urban areas are being impacted more than rural areas.
- Values have dipped since 2006 and 2007, which was the basis for the reappraisal.
- Once results are known, it will be communicated to the Treasurer
- Only residential properties are being revalued
- Goal is fair assessment
