Special Presentation:

Madison Primary School – 2nd Grade, Mrs. McKinney:

Explained intelligences, how math curriculum targets individual learning styles; how curriculum promotes future learning goals (i.e., third grade); how math facts, addition and subtraction are used for problem solving. Game playing targets two-digit addition in a fun way. Some learners get much from music. Students demonstrated games, exercises and musical learning in the curriculum.

Construction Update – Kim Plummer and Vic Keykens:

The project is 52% complete, roofing is 85% complete, brick veneer is 90%, interior metal framing is 75%. The project is still on schedule for completion by July 15. The work session scheduled for February 1 will be needed to vote on the authorization to bid on several packages, and will need to be advertised. The contingency funds are in good shape.

Mr. York: Unused funds will be going to technology such as the phone systems, smart boards, projectors, and wireless connectivity. We will be going from 57 to 12 phone lines, representing significant savings.
